In 1768 John Smith is listed on Armistead Churchill's tithable list for the Center District as the overseer of Elizabeth Bunbury's property. This appears to be the same individual known as John Smith of Bunbury (various spellings), and later as John B. Smith. At times he was referred to simply as John Smith. The middle initial apparently was adopted to distinguish himself from the numerous other John Smiths living in Fauquier.

The Bunbury family was an influential family of early King George County. Elizabeth, widow of William Bunbury, resided in St. Paul's Parish in Stafford. Her Fauquier lands were on the "upper side" of Licking Run and neighbors over the years included Humphry Arnold, Wiley Roy, et. al. She seems to have completely divested the lands by 1784, giving them by deed to her nephew, Robert Townsend Dade.

It is not clear when John Smith's employment by the Bunbury family ended. In 1778 he is listed on William Pickett's Tithable list and he paid the tax that year for Charles Christy. The next individual listed on this 1778 list is Edward Ball whose property is known to have been in the vicinity of the upper areas of Licking Run, near Cedar Run. Also living in this vicinity was the family of William Spicer.

Sometime following 1778, John B. Smith removed from the Cedar Run area to Leeds Manor. In 1792 he leased land in Leeds for the lives of sons John, Soloman and Benjamin. (Fauq. DB 10, pg 494). In the following year he leased additional and adjacent acreage for the lives of children Reuben, Elizabeth and Frankey. (Fauq. DB 11, pg 408). Neighbors were Benjamin Ball, Edward Dulin, and Alexander Welch. Benjamin Ball lived at the confluence of South Branch and Carters Run, a short distance north of the Rappahannock.

In his 1815 will, John named several members of his family, including his wife. From this document, it is clear he had a family prior to marrying Rebecca Spicer. The un-named children can be inferred from marriage records and guardianship records which are very specific in reference to the wards being orphans of either John B. Smith, or John Smith (Bumberry).

Soloman B. Smith in 1816 was appointed guardian for his brother Samuel Smith. Charles Christy and John Rogers entered their securities in support of Soloman. John P. Smith was appointed guardian in 1818 of Rebecca, Joseph and Noah. Reuben B. Smith in 1826 replaced John P. as the guardian of Noah A. Smith. Consistent within these records is the fact that John A.W. Smith and Inman Horner entered their security bonds in support of John P. Smith. Thornton Christa (sic) and James Hailey were co-bondsmen for Reuben.

Daughter Catherine pre-deceased her father but is named in the 1815 will. She had married William Barrett 22 Nov 1790. On that same day Sarah, not named in the will, married Robin Gaunt. John Smith recorded his consent for both "Catern" and "Sary" to marry.

The John Dodd family seems to have played a close relationship to the family of John B. Smith. Dodd was a wealthy grist mill owner living on South Branch. His daughter Nancy married Benjamin Ball, Jr. 26 Jan 1807. Daughter Elizabeth married a John Smith 19 Dec 1796. Son George married Molly Smith, daughter of John Smith 20 Dec 1801. The John Smith who married Elizabeth Dodd appears to be John P. Smith, son of John B. Smith and

brother to Molly.

Another daughter, Nancy, married Charles Christy who had his taxes paid by John Smith (Bumbry) in 1778. A William Smith was the bondsman for the 1786 marriage. This man's identity is unclear but was a neighbor per the 1768 tax record.

John in his will referred to his daughter as Lucinda "Smith" and not by her married name of "Rogers" at the time the will was written. There seems little doubt however that the Lucy who married John Rogers is the correct individual. The marriage record states she is the daughter of John B. Smith. Further, John Rogers was the bondsman when Frances married James Haley. Rogers was also co-bondsman for Soloman in the guardianship of Samuel. Lucinda's marriage was only a few months prior to the dated will and reference to "Smith" likely was a remnant of a prior draft. "Lucy Roggers" was acknowledged in her mother's will.

While not fully traced, Benjamin and Reuben may have remained in Fauquier while the others removed by 1830.

Several questions remain, notably the identity of the William Smith who served as bondsman to the Christy-Smith marriage. This William, along with yet another John Smith, was neighboring John Smith, Bumbry's overseer, in 1768. This later John Smith is possibly the father of John Smith of Bumbry.

Also of question, the relationship, if any, of John B. Smith to John A.W. Smith who entered several securities in support of John P. Smith's quardianships of his half siblings. John A.W. Smith was however the County Clerk and he routinely gave his securities.

It is clear the identity of John's first wife is Anne Ball, daughter of Benjamin Ball and Anne Owen of St. Paul's Parish. Anne was born there 17 Jul 1745. She married a John Smith 26 Dec 1765 in St. Paul's parish. It is Anne's brother Benjamin, Jr. who settled in Leeds Manor in 1761 and who would have been John's neighbor. Further, researcher Louis Pondrum had within his notes that John P. Smith paid Benjamin Ball's remaining estate expenses in 1826. This would have been Anne's nephew and John P. Smith's first cousin.

John Smith who married Anne Ball in St. Paul's Parish (likely King George County at the time) was born 19 Jul 1746 to John Smith and Margaret Grigsby who in turn were married 5 Nov 1728. There is no birth record of a son William born to this couple.

John and Anne (Ball) Smith had a daughter Margaret, born 20 Nov 1766. This was the final record of John and Anne in St. Paul's. This Margaret Smith married Francis Scott and there is ample proof she is the daughter of John Smith by his first wife, notably a power of attorney in which Margaret Scott and her sister Elizabeth Quisenberry are attempting to obtain their inheritance from their father's estate from their step-mother, Rebecca Welsh.

Know all men by these presents that We Zacheus Quesenberry & Page Quesenberry & Elizabeth his wife of the County of Barren and State of Kentucky have Constituted and appointed and by these presents do constitute and appoint William Warder of the Said County and State our true and Lawful Attorney in fact for us and in our names and Stead to ask for demand and Receive of Alexander Wealsh and Rebeckah his wife Administrator & Administratix of John Smith Deceased of the County of Fauquier and State of Virginia all Sums of money that is due to the aforesaid Page Quisenberry & Elizabeth his wife and to Francis Scott & Margaret his wife as a legacy or part of the Estate of the aforesaid John Smith Decd we do by these presents vest our Said Attorney with full power and authority to Sue and prosecute to Judgment recover & receive the aforesaid Legacy & receipt for the Same & do execute and perform all manner of acts and things for the recovery thereof which we ourselves could do were we personally present and had done the same ourselves in our own persons & to appoint an Attorney or Attorneys under him for the purposes aforesaid & to revoke them at pleasure hereby ratifying and confirming whatever our said Attorneys may lawfully do in the above premises. In Witness whereof we have set our hands and seals this 5th day of April 1817.

Following his marriage, John Smith likely was employed by his father-in-law at the grist mill. John Dodd paid his tax for 1799.

John P. Smith does not appear to have used the middle initial 'P' prior to his marriage. Indeed, He is referred to simply as "John Smith" in the estate closing of his father-in-law. Aside from this, he is consistantly referred to with the middle initial up to the time he disappears from Fauquier records, about 1826.

Like his father, it seems the middle initial was adopted, probably to distinguish himself from other John Smiths,. notably John Puller Smith who resided in the Orlean area and is said to be the son of John Winn Smith. This John Puller Smith is sometimes referred to with the military ranking of "Captain". He served as a County Justice for Fauquier. He seems to have dropped the middle name in favor of the initial after 1826.

It has not been substantiated but researcher Louis Pondrum had within his notes that John P. Smith paid Benjamin Ball's remaining estate expenses.

The Land to be sold and devied among my husbands first children that he had by his first wife and my children that he had by me the rest of my property I desire to be sold and ____ divided among my own children Frances Haley Rubin Smith Lucy Roggers Samuel Smith Rebecke Smith Joseph Smith Noah Smith. I allso apont Rubin Smith and Samuel Smith John Roggers and James Haley my Executors to sel and divide the same, this being my Last Will _____.

August the 17 day 1820

At a Court held for Fauquier County, on the 27th day of June 1826.

This last Will and testament of Rebecca Welch dec'd was proven by the oath of John Rodgers, a witness thereto, and ordered to be recorded as a will of personal property--and on the motion of Edward Digges who made Oath thereto, and together with Thornton Christa, Joseph Smith, Noah A. Smith and John Rodgers, his securities, entered into and acknowledged a bond in the penalty of twenty four hundred dollars, conditioned as the law directs. Certificate is granted him for obtaining letters of administration on the said decendent's Estate, with her Will aforesaid annexed, in due form. And at a Court held for the said County, on the 28th day of August 1826 The said Will was proved by the Oath of Jas Rodgers, a witness thereto, and ordered to be recorded as a will of real estate.
